## **COLUMBARIUM (Niche) RESERVATION FORM**

Apply for the reservation of a Niche of the Columbarium, situated in the grounds of St Edward the Confessor, 104 Chatswood Road, Daisy Hill, Queensland.

### **Names of Internee:**

### **Fee:**

The Applicant agrees that the cost of the reservation and use of the Niche(s) is: \$400.00..... (hereinafter called 'the fee') and agrees to pay that sum to the St Edward the Confessor Parish (hereinafter called 'the Parish') within ninety (90) days of signing the Reservation Form.

The Applicant acknowledges that the fee does not include the cost of the Memorial Plaque(s). The cost of the memorial plaque and affixing it to the Niche will be payable by the Applicant when the plaque is ordered. The Parish will be responsible to liaise with the nominated signage company for the standard design and installation of the memorial plaque.

### **Period of Reservation:**

The Applicant agrees that the period of reservation of the Niche(s) pursuant to this agreement shall be twenty-five (25) years from the date of application approval. Request for ten (10) year extension at no extra cost shall be made by the interested party, in writing, within three (3) months prior to the expiration of the twenty-five (25) year period.

If the period of reservation is not extended, the Parish will then have the right to make the niche available for repurchase of reservation.

### **Obligations of the Parish:**

The Parish reserves the right to relocate all ashes and memorials at its own expense, should this Parish cease to occupy the property situated at 104 Chatswood Road, Daisy Hill, Queensland, should the property or structure be affected; should the Church be caused to be rebuilt; or should anything occur, which in the opinion of the Parish Priest, makes it appropriate to relocate the ashes.

The Parish agrees to maintain the Columbarium, Niches and memorial plaques in good order and condition during the Period of Use. The Parish accepts no responsibility for any damage caused to the Columbarium, Niches, Ashes and memorial plaques, regardless of how such damage is caused, whether by negligence of the Parish or anyone else.

The Parish has the right to remove artificial flowers, statues, permanent wreaths or sprays, boxes and toys and anything the Parish considers detracts from the presentation of the Columbarium.

The Parish agrees to give Special Remembrance for the deceased, in the Eucharist celebrated at St Edward the Confessor Church, Daisy Hill, normally the following day after the interment of the ashes.

**Applicant's Warranty:**

In the event that the Applicant is entering into this Agreement on behalf of the Internee, then the Applicant warrants that he/she has full and proper legal status and authority to enter into this Agreement on behalf of the Internee.

In consideration of the terms of this Agreement, the Applicant indemnifies and agrees to save harmless the Parish, and The Corporation of the Trustees of the Roman Catholic Archdiocese of Brisbane, for any loss or damage howsoever arising from this Agreement or anything done or omitted by them or either of them pursuant hereto for which they or either of them could be liable to the Applicant or the Internee or the Executors, Administrators or the next of kin thereof.

**Termination:**

The Applicant has the right to cancel this agreement at any time prior to the interment of the ashes by giving notice in writing of such cancellation to the Parish, in which case all monies paid by the Applicant shall be refunded in full.

The Parish may terminate this Agreement if the:

- Columbarium or the Niche to which a particular agreement applies is damaged wholly or partly and the Parish decides not to repair or replace the Columbarium or Niche containing the interment;
- Parish no longer owns or operates the Parish Grounds;
- Parish decides to no longer keep and maintain the Columbarium.

**Privacy:**

In this agreement personal information is disclosed by the Applicant that is necessary for the Parish to perform its functions. The Parish respects privacy. Any personal information which is provided by the Applicant will be used and disclosed by the parish so that it can provide the services that have been requested, or otherwise to enable the Parish to carry out its functions.
